Admin	Permissions: Inbox	New permission Inbox: allowing inbox on both web & mobile app for communication/notifications
Admin	Permissions: Notes	Ability to view, edit, delete, download notes/notes attachments split into subsections: Patient, Employee, User, Physician
Admin	User Notes	Admin - Users - now have a notes section
Billing	A/R	Removed paging on A/R screen
Billing	A/R Days Open	Days open will now turn red if exceeds average time between billing and payment from that payer
Billing	A/R Past Due	Advanced filter now includes 'Past Due Only' check box to limit to claims exceeding the above average
Billing	Billed Amount	Added Billed Amount column back to A/R page
Billing	Payer Billing Code Report	Updated the Payer Billing Codes Report to include bill rates/discounts
Billing	Service Code: POS	Billing Place of Service may now be set at individual service code level (still defaults to payer level setting)
Calendar	Employee Phone Icon	In left pane visit edit - added phone icon to call directly from site from Employee tab
Calendar	FCNA Visits	If service type is FCNA scheduling visits is done without service codes/segment & Cubhub converts in the background
Calendar	Make-Up Visit	If an assignment was a make-up visit and incorrect date was indicated this may be corrected in the assignment
Calendar	Service Type Filter	Advanced filter updated to include Service Type Filter
Calendar	Units Displayed	In individual assignment view added back unit counts
Client	Assessments +	In assess when adding rows to a table (diagnosis codes, objective tests, OASIS) moved + to bottom
Client	Auto Cert Dates	If team setting exists current cert and next cert will be auto created in the assess/eval re-assess/re-eval

Client	Chart: Print Multiple	In chart: visits & assess added ability to select service type(s) user wants to print multiple of
Client	FCNA Assess	In the FCNA Assess POC each visit time limit may be set and is then required to be met in the calendar when scheduling
Client	FCNA Assess	In the FCNA Assess master task list created so user can easily select tasks for specific client needs
Client	FCNA Assess	In the FCNA Assess tasks may be marked with a specific day of the week
Client	FCNA Auths	If patient auth is service type FCNA 'ignore CAN overlap rules' check box added to allow calendar to ignore overlap rules
Client	FCNA POC	485 for FCNA service includes list of all Tasks and frequency as set in the POC
Client	LPR service type label	Added the service type label to the LPR page so user can easily identify which LPR they are working in
Client	Notes Attachments	Added a visual attachment count to client notes
Client	Therapy Goal Baseline	Baseline of a goal may now be captured in an initial Eval or Re-Eval
Client	Therapy Make-Up Visits	New Report: Therapy Make-Up Visits
Clinical	Make-Up Visit	At clock in of therapy visit user will be asked to indicate if this is a make-up visit - reportable
Employee	Pay Rates (limiting)	Pay rates now limited and may only be added once to each employee (Patient Specific excluded from rule)
Faxes	All headers filterable	Updated fax page (all filters) to show a filterable date of last action (sent, received) and order to be descending
Mobile	Inbox	If user has permission to Inbox and is an employee who uses mobile app they will have access to their inbox
Team	Auto Cert Dates Setting	Team setting added to allow for auto-cert dates to be auto created in assess/eval and re-assess/re-eval
